VOTING INSTRUCTIONS

READ THIS BALLOT CAREFULLY BEFORE MARKING

- 1. Make your selection by placing an "X" inside the box next to the name of the candidate of your choice using blue / black ink. No Pencil. No other marks should be used. Your ballot will be VOID if you vote for more than one candidate.
- IF YOU MAKE A MISTAKE, YOU MAY COMPLETELY CROSS OUT THE VOTING ERROR AND CLEARLY MARK AND INDICATE YOUR CORRECTED CHOICE.
- 2. After marking your ballot, please sign the statement on the bottom of the ballot. Place the folded ballot inside Business Reply Envelope, seal. place a stamp on the envelope and mail as soon as possible. Please return your ballot in the Business Reply Envelope provided. IF YOU DO NOT SIGN THIS BALLOT, IT WILL BE VOID.
- 3. ALTERNATIVELY, you may vote in person between 11am-7pm CST / 10am-6pm MST on MARCH 10, 2020. If you choose to vote in person instead, you will need to surrender this ballot at the voting location. Find your voting location at: demnpl.com/primary
- 4. YOU MAY ONLY VOTE ONCE. If a voter mails in a ballot, the mail ballot will be counted and they will not be able to vote in person. *All eligible ballots will be tabulated on March 10, 2020. This election will be certified by Global Election Services.
