

A Resolution to Reject the Certified Results of the 2020 Presidential Election

The Executive Committee of the Republican Party of St. Croix County having been duly elected by “we the people” of the Republican Party of St. Croix County submit this resolution to the legislators of the State of Wisconsin.

WHEREAS The Legislative Audit Bureau report, The Assembly Committee on Campaigns and Elections investigation and hearings, The Wisconsin Institute for Law and Liberty (WILL) investigation and report, and Michael Gableman’s investigation and Second Interim Investigative Report, which was presented to the Assembly Committee on March 1, 2022, all found significant inconsistencies and discrepancies in the 2020 election, and

WHEREAS The 2000 Mules Documentary, using publicly collected evidence of geo tracking and municipal video surveillance, irrefutably proves election fraud occurred in the State of Wisconsin during the 2020 Election in the form of ballot trafficking through drop boxes, and

WHEREAS the Wisconsin Supreme Court has ruled that the use of drop boxes in the 2020 election was illegal with the majority decision, authored by Justice Rebecca Bradley, said, “Only the legislature may permit absentee voting via ballot drop boxes. WEC cannot. Ballot drop boxes appear nowhere in the detailed statutory system for absentee voting. WEC’s authorization of ballot drop boxes was unlawful...”, and

WHEREAS in light of the Supreme Court’s ruling the Wisconsin Election Commission (WEC) illegally circumvented their State Legislators by conducting the 2020 elections in multiple illegal ways, including allowing ballot harvesting, ballot trafficking, the use of ballot boxes not under the observation of election officials, encouraging people to register as indefinitely confined, not following the law related to voting at nursing homes, encouraging clerks to cure ballots with incomplete information, and registering voters without verified picture identification, and

WHEREAS that under Wis.Stat. 6.84(2), “ballots cast in contravention of the procedures specified in those provisions may not be counted. Ballots counted in contravention of the procedures specified in the provision may not be included in the certified result of any election,” and

WHEREAS numerous expert individuals and organizations have proven data of election fraud, abnormalities and statistical irregularities. i.e. True the Vote, Mike Lindell, Representative Tim Ramthun, Representative Janel Brandtjen (Wisconsin Assembly Election Commission), and

WHEREAS Speaker Robin Vos has admitted widespread election fraud, and Senator Patrick Testin has admitted the illegality of the use of drop boxes across the State of Wisconsin, and

WHEREAS testimonies have been given from Dominion whistle blowers, clerks, and election workers that testify as to the fraud, manipulation and machines actually changing the vote, and

WHEREAS we submit that substantial election fraud in key metropolitan areas significantly affected the results in five key States in favor of Joseph Robinette Biden Jr., and

NOW, THEREFORE BE IT RESOLVED, The Republican Party of St. Croix County Wisconsin, formally rejects the certified results of the 2020 Presidential election, and we hold that acting President Joseph Robinette Biden Jr. was not legitimately elected by the people of the United States,

BE IT FURTHER RESOLVED that we call for ALL legislators to adhere to their sworn duties [“swear (or affirm) that I will support the constitution of the United States and the Constitution of the state of Wisconsin, and will faithfully discharge the duties of said office to the best of my ability, so help me God.” Wisconsin Constitution Article IV: Section-28] to convene to decertify the 10 presidential electoral votes due to the fact that all ballots that were delivered into illegal receptacles are null and void and cannot be counted, according to Wis. Stat.6.84(2). The legislature cannot certify something that is null and void,

BE IT FURTHER RESOLVED that any legislator who fails to adhere to the Constitution has not only violated their oath of office, but broken the law,

AND BE IT FINALLY RESOLVED, that we the people of St. Croix County are standing up in opposition to the fraud and corruption of our election, and calling for the decertification of the 2020 presidential electoral votes and for law and order to be upheld.
